STATE NEWS

RN Single State License Renewals Due December 31, 2022

The Alabama Board of Nursing (ABN) reminds registered nurses (RN) holding Alabama single state licenses (SSLs) that they are required to renew no later than December 31, 2022. Unfortunately, at this point, renewal numbers remain critically low, with nearly 64,000 RNs still having failed to renew their licenses.

As a reminder, the rules have changed this year, and renewal will close at 4:30 p.m., December 31. Any SSL RN who fails to complete renewal prior to that time will lapse and will no longer be legally authorized to practice. You may direct questions or concerns to Licensing@abn.alabama.gov.

COVID-19/INFECTION CONTROL UPDATES

Clarification on When a Facility Needs to Make Intervention Changes Based on Community Transmission

The ANHA has received several emails and calls regarding Intervention changes needed based on Community Transmission rates. We have contacted ADPH, and they contacted CDC to make sure we are all on the same page with interpretations. Listed below is the question asked and the answer received:

When should health care facilities make changes to interventions based on changes in community transmission levels?

Some CDC infection prevention and control recommendations for healthcare settings are based on <u>Community Transmission levels</u>. In general, healthcare facilities should consider checking their local Community Transmission level weekly. When a healthcare facility's Community

Transmission level **increases** and the increase results in a change in the <u>recommended</u> interventions, the new interventions should be implemented as soon as possible. When a health care facility's Community Transmission levels decrease into a category that corresponds with relaxation of an intervention, facilities should consider confirming the reduction is sustained, by monitoring for at least two weeks, before relaxing the intervention.

Changes to Reporting Injuries and Illnesses

Employers must connect their Injury Tracking Account to a Login.gov account to submit their 2022 workplace injury and illness data next year (see the Safety Q&A below for more information).

Why must employers create a Login.gov account to submit their 2022 workplace injury and illness data to OSHA?

- Login.gov is a secure sign-in service that allows the public to access government applications using one account and password. Since October 2022, the OSHA Injury Tracking Application (ITA) requires you to create an ITA account and then a Login.gov account to report your establishment's injury and illness data.
- You must use the same email address for your Login.gov account that you use to access ITA to connect the ITA application with Login.gov. If you already have a Login.gov account with the same email address as your ITA account, select the "Sign in with Login.gov" button on the "Injury Tracking Application Login" screen and login to the ITA application. Step-by-step instructions on how to create your Login.gov account are available online.

Updated CMS Resources

The Centers for Medicare and Medicaid Services (CMS) updated resources on the Nursing Homes website. Specifically, the Medicare and Medicaid Programs; Reform of Requirements for Long-Term Care Facilities portion of the website.

CMS Releases Revisions to the Special Focus Facility Program

The Centers for Medicare and Medicaid Services (CMS) has released a revised Special Focus Facility (SFF) Program policy memo <u>QS0-23-01-NH</u> and updated the monthly <u>SFF posting</u>. These revisions are meant to increase the requirements for completion of the program and enforcement for facilities that do not demonstrate improvement.

A high-level overview of key changes made in the revised memo is as follows:

- Adding staffing levels as a consideration for SFF selection: CMS has directed states to consider a facility's staffing level when selecting facilities for the SFF program. CMS recommends if a state is considering two candidates with a similar compliance history, it should select the facility with lower staffing ratios/rating as the SFF.
- Increased Criteria for Completion of the Program: CMS has added a threshold that prevents a facility from exiting based on the total number of deficiencies cited. To graduate from the program, facilities must complete two consecutive standard health surveys, with no intervening complaint, LSC, or EP surveys with 13 or more total deficiencies, or any deficiencies cited at scope and severity of "F" or higher.
- **Involuntary Termination:** SFFs with deficiencies cited at immediate Jeopardy (IJ) on any two surveys (standard health, complaint, LSC, or EP) while in the SFF program, will now be considered for discretionary termination.
- **Increasing enforcement actions:** CMS will impose immediate sanctions on an SFF that fails to achieve and maintain significant improvement in correcting deficiencies on the first and each subsequent standard health, complaint and LSC/EP survey after a facility becomes an SFF. Enforcement sanctions will be of increasing severity for SFFs

- demonstrating continued noncompliance and failure to demonstrate good faith efforts to improve performance.
- Incentivizing sustainable improvements: CMS will closely monitor graduates from the SFF program for a period of three years to ensure improvements are sustained. For SFFs that graduate but continue to demonstrate poor compliance identified on any survey (e.g., actual harm, substandard quality of care, or IJ deficiencies), CMS may use its authority to impose enhanced enforcement options, up to, and including discretionary termination from the Medicare and/or Medicaid programs.

CMS Releases Memo on Fire Safety Evaluation System

The Centers for Medicare & Medicaid Services (CMS) finalized new mandatory values in August 2022 for the Fire Safety Evaluation System (FSES). CMS this week released revisions to the <u>FSES memo</u>, which negate the need for a waiver and now allow SNFs to once again achieve a passing score on the FSES without any impact on the fire safety of the facility.

Revised CMP Reinvestment Application and State Plan Resources

The Centers for Medicare and Medicaid Services has revised the CMP application and State plan resources on the CMS Civil Money Penalty Reinvestment webpage. The revisions clarify operational instructions such as prohibited uses of CMP funding, requiring letters of support from all nursing homes participating in CMP-sponsored projects, and providing new or updated responses to the FAQs. The American Health Care Association (AHCA) has updated its three-day stay benefit period waiver resource to incorporate the recent PHE extension and ICD-10 guidance updates. Read More.

SNF Provider Preview Reports - Now Available

The Skilled Nursing Facility (SNF) Provider Preview Reports have been updated and are now available. These reports contain provider performance scores for quality measures, which will be published on Care Compare and Provider Data Catalog (PDC) during the January 2023 refresh. The data contained within the Preview Reports are based on quality assessment data submitted by SNFs from Quarter 2, 2021 through Quarter 1, 2022. Additionally, the Centers for Disease Control and Prevention (CDC) COVID-19 Vaccination Coverage among Healthcare Personnel (HCP) measure reflect data from Quarter 1, 2022. The data for the claims-based measures will display data from Quarter 3, 2019 through Quarter 3, 2020 through Quarter 3, 2021 for this refresh, and for the SNF Healthcare-Associated Infections (HAI) measure, from Quarter 4, 2020 through Quarter 3, 2021.

Providers have until **November 14, 2022,** to review their performance data. Corrections to the underlying data will not be permitted during this time. However, providers can request Centers for Medicare & Medicaid Services (CMS) review of their data during the preview period if they believe the quality measure scores that are displayed within their Preview Reports are inaccurate.

To locate the SNF Provider Preview reports, please follow these steps below:

1. Log into the CMS Network (CMSNet) using the CMSNet login credentials.

- 2. Log into the Certification and Survey Provider Enhanced Reporting (CASPER) application using the Quality Improvement and Evaluation System (QIES) login credentials.
- 3. Select the Folders button from the menu bar in CASPER and a list of your folders will display.
- 4. Select the facility-specific, non-Validation Report (non-VR) folder. These folders will be named in the following manner:

For Nursing Home-based SNFs:

[State Code] LTC [Facility ID] (i.e., MD LTC XYZ123)

- 5. The Preview Reports are listed in descending order by Date Requested within this folder.
- 6. Select the desired preview report link to view the report.
